The Board Meeting of the Board of Trustees met in the Community Center, 4 Bell Street, Bellport, New York on Monday, January 22, 2024 with public viewing through video streaming and in person.

The meeting was called to order at 7:00 p.m. by Mayor Veitch with Trustees Mackin, Rohrmeier, Kuehn, Young, Village Attorney Moran, and Village Clerk Pontieri.

The flag salute was led by Mayor Veitch.

Updates by Mayor Veitch

- a. Village Clerk Mary Pontieri was sworn in by Mayor Veitch.
- Village Attorney Lisa Perillo was sworn in by Mayor Veitch.
 Village Attorney Perillo will serve from February 1, 2024 to February 1, 2025.
- c. Village Attorney David Moran presented a letter announcing his resignation effective February 1, 2024. Mayor Veitch and the Board accepted his resignation. Mayor Veitch thanked Mr. Moran for his years of service and accepted the letter with regret. Mr. Moran will continue with cases of ongoing litigation.
- d. Mayor Veitch reported on a meeting with Superintendent Alexcy Romero from Fire Island National Seashore (FINS). Superintendent Romero updated Mayor Veitch on the state of the barrier island. It continues to erode, and measures are being taken to prevent future erosions.
 - Due to the number of shark sightings, FINS is providing a course for lifeguards to handle shark emergencies on the beach. The course information will be made available to the lifeguards.
- e. Mayor Veitch continued with an update of Howells Creek. Howells Creek runs to the east of the golf course and flooding has caused erosion along the west side of the creek. The flooding on the westside and continues to degrade three (3) holes on the golf course. We are working with GEI an engineering firm to secure permits to dredge the mouth of the creek, among other solutions.
- f. The Village is waiting for the second reimbursement from FEMA for Superstorm Sandy in 2012 in the amount of \$711,000. Upon receipt of the money a third submission will be submitted.

- g. In early 2023, the Village received a \$2.8 million grant from HUD to improve the safety, and conditions of the marina and the docks at Ho Hum beach. This grant is a 75/25% split with HUD. Mayor Veitch assured the public that the marina is safe for boaters and residents. VHB, an engineering firm, is developing plans, securing permits and will manage the project. The first objective, before signing the agreement with HUD, is the submission of an Environmental report which VHB will spearhead on behalf of the Village.
- h. The Highway Department is working to finish up the Browns Lane/Shore Road project with hopes that the road will be open soon. Mayor Veitch thanked Nelson & Pope for their work with the DEC, of getting a "no-jurisdiction" letter allowing the project to move forward.
- i. The Village Audit is in the final stages and should be completed in late February. The process is moving along very well.
- j. Bellport Environment Committee is planning an event for May 25th with guest speaker Doug Tallamy. The location and time will be announced.
- k. Major Veitch read a statement regarding statements made by Brookhaven Town Supervisor, Daniel Panico. During his swearing in Supervisor Panico announced plans to improve North Bellport residents' access to the ferry, Ho Hum Beach on Fire Island, and all the services at the Bellport Marina. While the Fire Island beach is open to the public, the services at the Bellport Marina and Ho Hum are Bellport Village owned and funded by Bellport Village taxpayers.
- I. Mayor Veitch addressed the concern of residents and extreme flooding on Otis Lane, Thornhedge Road, and South Howells Point Road. The residents were reassured that in case of emergency the Fire Department and EMT will respond, and appropriate actions will be taken.
- m. The last item Mayor Veitch read was the State of Emergency Proclamation for January 9, 2024.

Trustee Updates

- a. Steve Mackin DPW, Kids Camp, Bellport Fire Department, South Country Ambulance, Suffolk County Police Department Trustee Mackin updated the public on a soft test done with the Fire Department and EMS on flooding in the Village. Both are ready to handle flooding. He reported that the SCPPD stated that petty larceny has declined.
- b. Nathan Rohrmeier Code Enforcement/Road Safety, Waterfront (HUD), Golf and Tennis, Grill Room Trustee Rohrmeier reported on the HUD grant. The HUD grant was approved in 2023 for \$2.8 million. The Village has selected VHB as an engineer and a new design for the bulkhead will be presented to the Board.
- c. Lorraine Kuehn Communication/Website, Business District, Senior Program, Vouchers, Special Project Arbor Day Trustee Kuehn reported that a 3rd exercise class was added to the Senior Program schedule. The classes will be on Monday, Thursday, and Friday. Next, she stated that she is working on qualifying the for Tree City in the Village. This will be the 2023 submission.

d. Michael Young – Zoning Board of Appeals, Architectural Review Board, Beautification Committee, Planning Board, Historical Preservation, Yacht Club/Sailing Foundation Trustee Young reported that attractive native plants are being planted on Shore Road.
