#### Board Meeting Minutes Monday, March 25, 2024 6:00 pm Public Hearing on Tentative Budget Monday, March 25, 2024 at 7:00 pm Board Meeting This meeting was held in the Community Center

### AGENDA

This meeting is open to the public in the Community Center, located at Bell Street. It is an inperson meeting and will be streamed on Zoom.

On a motion by Trustee Rohrmeier, seconded by Trustee Kuehn, and unanimously carried, the Public Hearing for the Tentative Budget was opened at 6:02 pm.

Mayor Veitch led the Pledge of Allegiance & Village Clerk called the roll. Trustee Steve Mackin and Trustee Mike Young were absent.

Opening remarks by Mayor Maureen Veitch

Mayor Veitch welcomed those present and turned the meeting over to Darcia Palmer, Treasurer to review the Tentative Budget.

Treasurer Palmer broke the presentation into 5 sections:

- General Fund Current Fiscal Year 2023-24 Overview
- FY 2024-25 Tentative Budget -General Fund Expenses & Revenues by Departments & Debt Service
- Real Property Taxes What is the Property Tax Cap, Property Tax Levy Trends, Tax Cap Calculation & Tax Bill Examples
- 5 Year Capital Plan
- Enterprise Fund Tentative Budget Overview

Treasurer Palmer reviewed each section for the Board. After the presentation, the Board had a few questions that Treasurer Palmer answered. Mayor Veitch praised Darcia for the precise, organized and easily understood budget presentation. The Board members expressed their thanks to Darcia.

A copy of the presentation is available at Village Hall for the public.

On a motion by Trustee Rohrmeier, seconded by Trustee Kuehn, and unanimously carried, the Board closed the presentation of the Tentative Budget.

On a motion by Trustee Kuehn, seconded by Trustee Rohrmeier, and unanimously carried, the Board Meeting was opened at 7:00 pm

Mayor Maureen Veitch presented a proclamation celebrating the 100<sup>th</sup> Anniversary of the Pattersquash Gunners Association to President Frank Miller and members. President Miller explained that the Pattersquash Gunners Association is a dedicated group that focuses on friendships and mentoring. He commented that the picture that was presented to the Village was painted by Steve Stanford and is titled red suspenders. A picture was taken of the members and they thanked the Village for the proclamation.

Mayor Veitch updated the Board and attendees on the following Capital Projects:

The 2.8 million grant from HUD which is a 75/25% split with the Village should be in place in the near future. The grant will provide safety at the marina and Ho Hum beach. VHB is the engineering firm that will manage the project and provide a timeline with critical dates. A meeting is set with VHB, Mayor Veitch, Marylou Bono, Peter Sarich, and Katie Mehrkens on Friday to discuss and summarize the project.

The Village is waiting for the second reimbursement from FEMA for Superstorm Sandy in 2012 in the amount of \$711,000 of which the Village will receive \$660,000. Upon receipt of the grant a third submission will be submitted.

The engineering firm GHI for Howell's creek flooding (east side of the golf course) is waiting for securing permits from the Army Corps of Engineers and the DEC.

The flooding on Browns Lane/Shore Road was minimal this weekend in part due to the installed drains. After completion of the project a rain garden will be created to help with any additional flooding.

The solar panels at Ho Hum beach are 30 years old and require new panels. Peter Sarich working with the DEC is securing the proper permits for replacement of these panels. The Village is actively working on the financing of the solar panels.

The Village's work crew will be finishing the gutters and leaders at Village Hall and siding is being priced.

He updated those present that Peter's on the Green will be open March 26<sup>th</sup> and the golf course will open April 1<sup>st</sup>.

Lorraine Kuehn Communication/Website, Business District, Senior Program, Vouchers, Special Project Arbor Day Trustee Kuehn reported that the donation for the Senior Program will be used for nonexercise programs such as Gateway tickets. The Arbor Day celebration will be held on April 19<sup>th</sup> at Kreamer Street School. The Bellport Garden Club has donated packets of seeds to be handed out at the celebration for each student.
