#### TRANSPARENCY

The best way to keep you informed about the village is to make information easily accessible to you. Starting earlier this year, there have been improvements such as:

- In March, we began sending residents email push notifications on Sunday mornings highlighting that week's calendar of events. If you'd like to receive these regular notifications, please fill out the form located at the bottom of the Village website (www. bellportvillageny.gov) or call Village Hall (631-286-0327) and we can add your name for you. To date, we have roughly 600 residents enrolled to receive these emails!
- Village meeting agendas are now available to you on the Village website days in advance so residents can plan to attend when issues of interest are being discussed. At all Board meetings we have an "open to the public" segment where you can make your views known. Board meetings are available on zoom and are recorded for later viewing.

- We have improved the quality and detail of Village meeting minutes so you can get up to speed on issues if you have missed a meeting. Note: Meeting minutes are approved by Board members at the next Board meeting, so minutes will be posted on our website the following month. For example, February's meeting minutes are approved and posted in March.
- Lastly, the Village website has been rearranged to make the most frequently visited features easier to see and use.

Improving communication and transparency is a work in progress. We will continue to update our website, and our next task on improving communication is securing the audio and video equipment needed to bring meetings to you in a more seamless fashion.

#### FINANCIAL RESPONSIBILITY

As your elected officials, the Board is responsible for developing policies, monitoring financial operations, financial planning, and ensuring that we have audits conducted on behalf of the village. The fiscal year runs from June 1 through May 31 each year.

The day-to-day financial responsibility is in the hands of our Village Treasurer Darcia Palmer. Here is what our treasurer's office has been up to:

- The 2024-2025 budget process began in January and was approved by the Board on April 22. The process for building the budget included extensive meetings, gathering information with each department head, the Treasurer, and the Board; six public meetings; and a public presentation from the Treasurer on March 25. Village residents remarked that this presentation was the most comprehensive and easily understood budget presentation in recent Village history.
- On Saturday, May 11 at 11am at the Community Center on Bell St., Jay Diamond (a member of the Budget and Fiscal Policy Committee) and Treasurer Darcia Palmer will present and explain the budget once again for residents who wish to learn more.
- In addition to the annual budget process for 2024-2025, our Treasurer is responsible for creating a five-year financial plan for major projects that the Village needs. This includes infrastructure repairs such as streets and sidewalks and other major expenditures. The planning is led by Darcia Palmer who will work closely with the Board and with input from members of the Budget and Fiscal Policy Committee.
- Every payment that the Village makes is reviewed monthly by our Treasurer's office, a Trustee, and me. Trustee Lorraine Kuehn has that responsibility and performs it with a keen eye to ensure that our expenditures are carefully reviewed before any money is spent.
- We are nearing the completion of the 2023-2024 fiscal year audit which is being conducted by the outside auditing firm of Cullen and Danowski, LLP. Those results will be shared with the public in the coming weeks. Recommendations from the outside audit will help us continue to improve our financial and operational procedures.

#### **ENVIRONMENTAL STEWARDSHIP**

As the Board liaison to the Bellport Environmental Committee (BEC), an advisory body, I am thrilled to update you on some of the BEC's recent projects:

On May 25, from 4pm to 6pm at the Community Center, nationally recognized expert Doug Tallamy will be presenting strategies for Village residents on creating habitats for pollinators in your own backyard.

- This Spring our Department of Public Works (DPW) will be installing elegant bike racks at seven locations throughout the Village. This new bike rack network is a joint project between the Village and the Bellport Village Program Fund.
- This year marks the third year of weekends and holidays free from the noise, vibration, and pollution of gas-powered leaf blowers and hedge trimmers, thanks to the recommendations of the BEC and other concerned community members.



• The ever-popular pre-season Ho Hum Beach Clean Up will be on May 18 (rain date May 19). The end-ofseason date will be announced in the coming months. Notice of these events will be posted on the Village website and in the weekly email notifications.



 The BEC's most ambitious project to date is the 1000 Yards Campaign. Looking ahead, Bellport Village is going to participate in the Clean Energy Communities Program, joining more than 20 other Suffolk County towns and villages and the State of New York to address the causes and consequences of our environmental challenges. I extend our heartfelt gratitude to the members of the BEC for their contribution to these important initiatives!

#### TRAFFIC SAFETY



This administration continues to proactively address the nationwide problem of speeding and reckless driving. Traffic calming and pedestrian safety continues to be a priority and a challenge.

 Now that the winter months are behind us, the traffic monitor sign (that indicates when motorists are speeding) has returned to our

roads, not only reminding drivers to slow down but also tracking speeds and saving the data. Sharing this data with the Suffolk County Police Department's Fifth Precinct will enable the officers to track peak speeding times and deliver more targeted speed enforcement.

- Trustee Steve Mackin has been working closely with Representative Dominick Thorne to install pedestrian crosswalk signs at intersections identified as the most dangerous.
- Of course, one of the biggest solutions to traffic calming is you
   everyone is responsible for abiding by traffic laws and making
   the roads of Bellport Village a safe place for all. Please commit to
   adhering to our local speed limit of 30 MPH.

#### VILLAGE INFRASTRUCTURE

The Village's infrastructure - buildings, roads, sidewalks, solar panels, bulkheading and more – are in dire need of improvement. Responsibly leading existing projects and initiating new ones has been a focus of our time and energy.

We have been fortunate to have the expertise of our Building Departments' own Marylou Bono and Peter Sarich to help with permitting, planning, site inspections, and project management.

Key projects and news include:

## EXCITING GRANT NEWS!!

The Village of Bellport is thrilled to announce that it has been allocated \$3.33 million in FY24 Community Project Funding for its Howells Point Coastal Resiliency Project. We would like to thank Representative Andrew Garbarino, Senator Kirsten Gillibrand, and Senator Chuck Schumer for ensuring that this project was included in the recently passed FY24 federal appropriation package.

The Howells Point project will help preserve Bellport's shoreline against erosion and storm damage and will protect against flooding and ensure the safety and resilience of the Village for vears to come.

- Completing the work on Village Hall includes installing gutters and shutters, shingling and painting to return the building to its historic condition. This project is being led by our own DPW with experienced carpenters and sheet metal workers along with input from James Carson, Chair of the Village Historic Commission.
- We are assured by our DPW that the Brown's Lane/Shore Road roadway, which has been closed for way too long, will be open for vehicle and foot traffic in May. We appreciate the work of the DPW, Nelson + Pope (for helping secure permitting) and Paul Warner, a village resident with an engineering background and road design experience. We look forward to reclaiming this beloved walking route!
- The HUD Marina Project is a \$2.8 million grant earmarked for improving safety and refurbishing both the Bellport and Ho Hum marinas. This grant is a 75/25 grant, meaning 75% of the project cost is covered by the HUD grant and 25% is covered by the Village. Over the last few months, we, along with the dedicated members of the Waterfront Commission and Peter Sarich vetted qualified engineering firms and selected VHB to lead the first phase of the project. Next phase is to complete the Environment Review of the project.
- The solar panels at Ho Hum Beach are the only source of power at the beach. The panels are nearly 30 years old (well past their useful life) and need to be replaced. Securing a new solar field (on the same footprint as the current ones) requires coordination with regulators, solar experts and identifying funding solutions as part of the project scope. Each week we are closer to having solutions on these fronts so that we can move ahead. Of course, we will keep you posted once we do.
- In early April, we submitted a grant request for improving cybersecurity and digitizing records for preservation and historic research. We will learn more about that later this year and are working on record clean-up in preparation for the possibility of those funds.

#### STRENGTHENING THE TEAM IN VILLAGE HALL

### **NOT-FOR-PROFIT FEATURE**

In each edition of The Scooter, we are going to highlight the work of one of the not-for-profits and in this issue, we are proud to feature Friends of Bellport Bay (FoBB):





**Friends of Bellport Bay (FoBB)** was founded by Katia Read and Thomas Schultz in 2015, and currently has four co-directors: Ellis Kocay, Maria Slavnova, Christina Woodard, and Larissa Chraim.

The goal of FoBB is to restore the ecosystem of the Great South Bay by planting oysters. These extraordinary shellfish act as a natural filter capable of removing toxins from the water.

Since its inception, FoBB has planted 3.5 million oysters on the bay bottom surrounding Bellport, which has significantly mitigated nitrates and other pollutants that have made it into our water. Now in their ninth season, FoBB aims to plant another 1.5 million oysters, which will bring the total to 5 million oysters planted in Bellport Bay.

Due to FoBB's success, the Brookhaven Town Board voted unanimously to double the size of the protected shellfish management area from two to four acres in January 2024, ultimately bringing back harvesting and recreational fishing to benefit the regional economy!

#### FOBB INTERNSHIPS AVAILABLE.

FoBB also runs a paid internship program for high school and college students who have an interest in environmental marine biology. To apply for a summer internship please send a letter and resume to Maria@Fobb.com.

The young marine biologist interns will learn from a professional team of aquaculture specialists from Cornell Cooperative Extension of Suffolk County (CCESC), as well as work with a certified scuba diver, and other volunteers and professionals.
